Submitting a Manuscript

File names. Word files should be named after the first author (eg. Hawa.doc)

Editorial correspondence. Acknowledgement of receipt and other correspondence will be addressed to the corresponding author indicated on the first page of the manuscript.

Manuscript Preparation

Format. Manuscripts should be typed on one side only of B5 size paper (format 7.17 x 10.12 inch; 182 x 257 mm), using, unless stated otherwise, standard 11 points Times New Roman, double spaced with wide margins (25 mm) and the sheets numbered consecutively. All headings must be set as center alignment.

Title, authors and addresses. The title should be informative but concise. It should be followed by a list of the authors, with first names as initials only and preceding the name and with each name separated by a comma, except for the last two which are separated by 'and'. The list of names should be followed by a list of authors' addresses. The address and author for correspondence should be indicated by asterisk and superscript numbers where there is more than one author and address. Include the telephone number, fax number and e-mail address of the corresponding author, a running title of up to 15 words.

Abstract. This should indicate concisely (in less than 250 words) the scope and main conclusions of the paper. The abstract does not need a heading. Please provide up to six additional key words.

Keywords. Up to a maximum of five keywords are required. They should be placed directly below the abstract.

Introduction. This should provide the current status of work in the relevant field and the reasons for carrying out the experiments, as well as clear statement of the objectives.

Materials and Methods. The description of experimental procedures should be sufficient to allow repetition of the work. Except in the case of standard procedures, however, methods should be outlined even when reference is made to a published description. Commercial equipment and products used in experiments should be given as follows: product, company, city, country.

Results and Discussion. These should be presented in an orderly manner. Materials presented in tables should not be repeated in figures.

References. Articles cited in the text will be referred to by the name(s) of the author(s) with the year of publication in parenthesis. If both are in parenthesis, no punctuation separates the name(s) of the author(s) and the year of publication. Consecutive citations in the text are placed in chronological order and separated by commas. If there are more than two authors, only the first author's name is given, and this is followed by the phrase et al., which should be in roman, not italic, type (eg. Author 1986, Author1 & Author2 1990, Author et al. 2002). References should be listed alphabetically at the end of the paper on a separate sheet.

Units and quantities. SI units are preferred. Others should be related to SI units at the first mention. Numbers preceding units should be written as numerals, those preceding other items up to nine should be spelt out, e.g. 8 cm, 2 days, nine fields, 10 leaves. Units should preferably be explicit, e.g. 1 g/L or 1 g L⁻¹ rather than 0.1% w/v. whereas gram per litre can be indicated as g L⁻¹, spores per litre is written as spores per L.

Tables. Each table should be self-explanatory and typed on a separate sheet with an appropriate caption. Tables should be referred to in the text with arabic numerals as e.g. Table 1, etc. In the results section, do not state "Table 1 shows the results of a given test"-describe the results of the test and then indicate which table shows them. The description should not repeat the results of the table but can draw attention to particular or general features of them. Refer to tables in the sequence in which they are presented.

Figures. These should be numbered in a separate series and referred to with arabic numerals in the text as, e.g. Figure 1, etc. Figure legends should be self explanatory and grouped together on a separate sheet. Subdivisions within figures should be labeled with lower case letters, e. g. a, b and c, etc. and these should also be used in the figure captions, footnotes and in the text.

Colour. Authors of articles with coloured illustrations will be charged as a contribution towards the cost of printing.

References. All journal titles should be written out in full. Examples are given below.
